Dullingham Parish Council believe that this lies outside the development envelope and if confirmed this should be a significant ground to refuse. It is adjacent to a listed building and may be considered too large for the location.

#### 23/00201/FUL Site west of 22 Station Road, Dullingham

Erection of a two-bedroom bungalow

Dullingham parish council request this application be refused.

This development would create overdevelopment adversely affecting the character and setting of Dullingham House as well as being harmful to the Historic parkland which is in the English Heritage Register.

The proposal would create substantial harm to the listed building as well as the parkland due to the location and scale which is not outweighed by any benefits as required by NPPF Chapter 16. The proposed site would be harmful to conservation and heritage protection objectives as it moves building further into the heritage landscape with cumulative development encroaching further into the conservation area and toward a listed building. This application is contrary to guidance in the local plan 2015 within ENV1, ENV2, ENV11, ENV12 and ENV15 as well as NPPF.
